

## Meals on Wheels

Meals on Wheels are provided on a short-term or long term basis to home bound elders age 60+ who are unable to prepare a nutritionally balanced noon meal for themselves AND are unable to attend a Congregate meal site.

### **Volunteers:**

- ★ Deliver the meals Monday through Friday and are reimbursed for the use of their vehicles.
- ★ Help pack meals.

### **Well-being Checks:**

Meals on Wheels are more than a hot lunch. The volunteers who deliver the meals ensure daily contact and a "well-being" check for elders who are alone during the day.

### **Requirements:**

- ★ Elders are asked to call and give 24-hour notice for the start of home meal delivery (413-773-5555 or 978-544-2259) or to resume or end the service (413-772-7702).

- ★ A minimal voluntary donation is requested.

### **Senior Dining Center Meals are:**

- ★ Hot noon meals provided for elders age 60+ and their spouse of any age.

- ★ In a congregate setting at one of eight Senior Centers or nine Luncheon Clubs listed on the inside of this pamphlet.

### **Added benefits:**

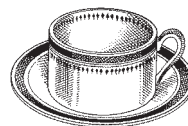
- ★ Socialize with friends & neighbors.

- ★ Often the Senior Dining Centers (meal sites) located at the Senior Centers offer a variety of programs such as health clinics, recreation programs, exercise classes, and craft classes.

### **Requirements:**

- ★ Reservations must be made one day in advance by 11:30 a.m. Contact information is listed inside this pamphlet.

- ★ There are no financial eligibility requirements. A minimal voluntary donation is requested.

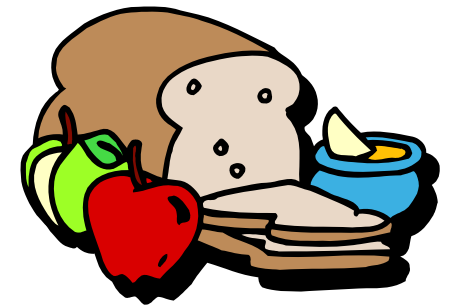

## The Meals:

- ★ Are planned to provide between 600-800 calories, no added salt and one-third of the daily nutrients per meal as recommended for older adults.
- ★ Contain no more than 30% of the daily fat allotment. Non-sugar desserts are available for those who require this type of dietary item. Therapeutic meals to support a variety of medical conditions (like heart disease or kidney disease) can be prescribed by your health care provider by calling 413-773-5555 or 978-544-2259 and asking for the Meals on Wheels program.
